IN 2008, WE FOCUSED ON MARINE CONSERVATION, FEDERAL FOREST MANAGEMENT, CLEAN WATER, CLIMATE CHANGE AS WELL AS WORKING WITH MEMBERS OF THE NATIONAL ASSOCIATION OF COUNTIES' PUBLIC LANDS AND ENVIRONMENT, ENERGY AND LAND USE COMMITTEES. FOR EXAMPLE, WE SUCCEEDED IN GETTING THE ENVIRONMENT, ENERGY AND LAND USE COMMITTEE TO REVERSE ITS POLICY ON CLEAN WATER. WE WORKED WITH COUNTY COMMISSIONERS AND FOREST ADVOCATES IN OPPOSITION TO BLM'S WESTERN OREGON PLAN REVISIONS. WE EDUCATED COUNTIES AND ENVIRONMENTAL ADVOCATES ABOUT COUNTY PAYMENTS, WHICH GOT A 4-YEAR REPRIEVE. WE RECRUITED PRO-ENVIRONMENT MEMBERS TO JOINT NACO'S PUBLIC LANDS COMMITTEE AND ASSISTED IN THEIR ANALYSIS OF RESOLUTIONS. WE WORKED TO DEVELOP THE MACK REEF I MARINE RESERVES PROPOSAL, WHICH WAS RATED THE HIGHEST OF ALL NEW COMMUNITY PROPOSALS BY THE STATE AGENCY STAFF ANALYSIS. WE BROUGHT OUR "CONSERVATION MAKES \$ENSE" BOOTH TO THE NATIONAL ASSOCIATION OF COUNTIES' ANNUAL CONFERENCE IN KANSAS CITY, MO. WE PRODUCED CONSERVATION LEADERS NETWORK'S QUARTERLY NEWSLETTERS, NETWORKER, AND PROVIDED MEMBERS WITH FUNDING OPPORTUNITIES FOR NATURAL RESOURCE PROTECTION AND RESTORATION.
